PLEDGE OF ALLEGIANCE

- **CALL TO ORDER:** Mayor Stein called the meeting to order at 6:00 p.m.
- ROLL CALL:Members present were Bob Lawson, Deborah Trboyevich & Bob Stein. Nancilyn
Meyer and Trevor Guyer were absent. All motions passed 3-0 unless noted
otherwise.

Staff present were Jestine Casey, Rick Rogich, Alan Johnson and John Dimich. Steve Hurd and Derek Vekich were also present.

- GUESTS: 1. Derek Vekich – sidewalks by Middle School. Vekich asked if there are plans for the city-owned sidewalks around the middle school because they are old and not being used. He was advised the plan is to leave as-is because it's not in the budget to remove and replace. It was discussed that the city could swap the city-owned triangle parcel next to the middle school for Vekich's removal of the city sidewalks. Motion Trboyevich 2nd Lawson to swap the city-owned, triangle parcel next to the middle school for Vekich's complete removal of the city sidewalks. All in favor. Attorney Dimich will draw up the contract. Vekich also stated that he incurred contractor costs to install a curb stop due to water pressure issues he was having. He felt that the water-pressure issues were caused by the city. Rogich thoroughly explained potential causes that weren't city related. Vekich was also advised that since the new valve was installed on his property, the city cannot legally touch it.
