- 10 Put up banners and hanging flower pots. Filled standing flower pots with dirt and placed.
- 11 Put out benches and bike racks.
- 12 Planted 25 white pines between large ballfield and Trailview addition. I don't expect all of them to survive but hopefully enough will and they will provide a barricade in the future to prevent snow drifting in that area. The trees were donated by Joe Pelawa.
- 13 Haul out the debris and yard waste behind the water tower. This has accumulated over the years and the edge of the bank is collapsing. We will be installing a no dumping sign there.
- 14 Found people are dumping north of North 2nd St in the area that was were the old Itasca Oil tank location. Will get that hauled out and place a no dumping sign there as well.
- 15 Replaced faded no semi parking sign on the West end of town.
- 16 Hauled all the old fluorescent bulbs to TBI for disposal.
- 17 Helped Coleraine put in the docks at the beach.
- 18 Filled a sink hole next to the bike trail on the West side of Main St. We filled this same spot last summer. We may have a leaking storm drain that is causing this.
- 19 Placed speaker system from the closet off the Club Room in the basement for bingo events. The old speaker system from the basement disappeared.
- 20 IRRRB Streetscape grant for \$11,500 for new bike racks and benches was approved. This is a 50/50 matching grant and monies from the Blandin Grant will be used for the match. Finalized and submitted signed agreement.
- 21 Marked pot holes on CSAH 61 on the east side of town. Reminded the County they need to be patched.
- 22 Finalized landscape equipment grant and submitted.
- 23 Cleaned up trees on bike trail that were knocked down during the last storm event.
- 24 Filled a sink hole in the city parking lot west of City Hall.

<u>Water</u>

- 1 28 disconnect notices sent out. 5 disconnects generated. 4 paid before the disconnect date and 1 was disconnected.
- 2 Power outage at pumphouse on 6/20 at 9:30 pm. Power back on at 9:00 am on 6/21. Coleraine also had no power and their emergency generator blew a coolant hose. I repaired the hose and filled with coolant so it could be put back online. Perhaps we need to look at our own back up generator. Luckily the tower was at 24' when we lost power. Tower was at 18' when power came back online. I was getting ready to switch to Coleraine water when we got power back.

- 3 Wellhead Protection Plan Part 2 amendment is in the final stage for the 60 day comment period. We need to set a public hearing for Wednesday, September 21st at 6:00 pm to address any comments.
- 4 Itasca County Soil & Water is requesting financial assistance from the cities in the County for helping to pay for a well identification program. See attached emails.
- 5 Lighting breaker at pump house kept tripping. Replaced breaker but it kept tripping. Found that the receptacles are wired in the same circuit as the lights and the dehumidifier compressor is making noises. Unplugged and will determine if it can be repaired, new one is \$1,500. Tore down dehumidifier. Tried new start capacitor for compressor motor, compressor still humming and kicking out breaker. Need new compressor motor or new dehumidifier.
- 6 KLM will perform scheduled maintenance on the water tower on July 19th, Will will go on Coleraine water on July 18th and drain the tower for inspection and cleaning.

<u>Sewer</u>

1 Performed weekly and monthly maintenance for Trailview lift station.

<u>Garbage</u>

1 Garbage hauled for June- 28.34 tons. Weekly average- 6.30 tons.

Vehicles/Equipment

- 1 JD Loader- having the same problems with the transmission as we had last fall. Called McCoy to look at it. They couldn't get it to fail.
- 2 ASV- change oil and filter, grease bogey wheels and all other fittings.
- 3 2014 John Deere Rider- replaced faulty clutch switch and broken linkage arm for the mulch assembly. Mulch assembly is binding. Lots of play in one pivot arm, tore down and bottom bushing was missing, made new bushing out of pvc pipe, ordered new bushings. Replace blades, last set, ordered 2 new sets.
- 4 Garbage Truck- made an emergency repair on an air line that blew on the way back from the landfill. Replaced with a new air line the next day.
- 5 2002 Chevy sander- replaced broken bracket for the deflector shield on the spinner assembly.
- 6 Water Wagon- installed new pump and wand for watering flowers.

<u>Buildings</u>

- 1 City Hall- cleaned as needed.
- 2 City Hall assessment grant has not yet been completed. Brian took pictures with his drone. Bolton & Menk added them to the addendum report and I submitted the addendum and the condition assessment report. Will wait to hear from the Historic Society if it is acceptable.
- 3 Put together cabinet for Library.
- 4 Put together new chair dolly for the basement and started going through chairs to find the good ones.

Hi Kevin,

No problem regarding the email- it's sometimes a little difficult to find the best email and contact person for some of this stuff.

For budget planning, this would be a project that we would complete next year, summer 2023. We plan to hire a seasonal employee to carryout this wellhead project that we would provide office space, computer equipment, and a vehicle if necessary to locate these wells. We've secured around \$8k so far for this project, but as I mentioned still have a bit to go.

We feel that the amount of resources that the state can contribute to the rest of the geologic atlas is well worth the investment of locating the remaining wellheads, but there is still a cost.

For now, we're looking for at least a verbal commitment/agreement from cities that are part of the wellhead program that they would be able to help fund this project. We don't necessarily need an exact amount, but an estimate would be helpful to plan if we'll be able to fund the project, which I'm hopeful for.

Hello Kevin,

I wanted to follow up regarding the Geologic Atlas. Identifying and locating unverified wells is a priority to protect water quality and completing this step would start the process of initiating the Geologic Atlas. The Geologic Atlas would be a tool that the entire county would be able to utilize and help better understand ground water flow, soils, aquafer production, and help identify areas that are of higher risk of contaminants.

As I mentioned, we have a \$10,000 shortage to complete this. I'm reaching out to the cities in the Itasca Wellhead Program and asking for a \$2,000 funding commitment from the city of Bovey to help locate these remaining 8,000 wells which will start the geologic atlas process. We would plan to hire additional seasonal staff here at the Itasca SWCD office for 2023 to complete this project but we need to make up this shortage.

Please let me know how much funding you might have available for this. If you have additional questions, you can call or email me, and I can help answer those.

Hello Kevin,

The <u>geologic atlas</u> helps explain where our water comes from and how it moves through the county underground. This information can help tell us things like what aquafers are available to homeowners for well water, where is the highest producing aquafer in an area, and can also help us identify areas that are at a higher risk of contaminants that have the potential to have a damaging effect on our groundwater.

A necessary first step in creating the geologic atlas for Itasca County is to verify all private wellheads in the county. There are around 20,000 wells in the county, approximately 8,000 of these wells are unverified and need verification to proceed with this process. Here is the link to the MDH Minnesota well index map layer, <u>https://mnwellindex.web.health.state.mn.us/#</u>. You do need to zoom rather far in your area for the well sites to appear, and you can click the box for "Unverified Wells" layer/label to get an idea of the number of unverified wells. These are the sites Itasca SWCD would be working to verify.

Depending on local support, SWCD staff availability, and project funding, Itasca SWCD may be able to start performing well locating in 2023 to verify the locations of around 8,000 wellhead sites which are not currently in the well index database. There is currently a \$10,000 shortage to fund the project and locate the remaining well locations- we are reaching out to you for assistance to reach this amount.

Again, locating all the wellhead sites in the county is the first step in moving forward with the Geologic Atlas. Please let me know if you may be able to assist with some funding for this project- and feel free to email or call (218-999-4435) me with any questions.
